- **Electronic funds transfer (Online Services)** - It's secure, easy, and convenient. You can make a single payment or schedule all four payments at once.
 1. On the Landing page, select **Make a Payment**.
 2. Select **No, I am not using a Letter ID**.
 3. Select **Individual** for the Customer Type.
 4. Select **Individual Income Tax** for the Tax Type.
 5. Select **Estimate** for the Type and Period.
 6. Complete the remaining fields.


